INVITATION TO BID

Sealed bids for **OMB/DFM Contract No. MJ1002000071 – Legislative Hall – Legislative Hall Parking Garage** will be received by the State of Delaware, Office of Management and Budget, Division of Facilities Management, by way of the Bonfire Portal at <https://DFM.bonfirehub.com> until **1:00 PM local time on November 06, 2025**. Bidder bears the risk of late submission.

Bids will be opened and read aloud at 2:00 p.m. local time on November 06, 2025 at the Haslet Armory, 122 Martin Luther King Blvd. S., Dover, DE 19901.

The project consists of the Construction of a new 3-story, 124,800 square foot parking garage, at the corner of East Water Street and Martin Luther King Jr. Blvd. South in Dover, Delaware. The scope of work includes all Civil, Structural, Architectural, Mechanical, Electrical, Plumbing, and Fire Protection Systems as indicated in the Bid Documents.

The Owner may extend the time and place for the opening of the bids from that described in the advertisement, with not less than two calendar days’ notice by certified delivery, facsimile machine or other electronic means to those bidders receiving plans.
